Oxnard Union High School District Serving Meals after school through the Supper Program

The Oxnard Union High School Nutrition Services Department to provide FREE meals after school through the Supper Program at the participating schools, see attached.

Free meals will be provided to ALL children, without eligibility documentation, who are 18 years of age and younger. The program will launch Monday, September 3, 2019 and run through June 16, 2020 (Monday through Friday). Please contact school cafeterias for information on serving times.

The Supper Program is federally funded and operated nationally by the U.S. Department of Agriculture (USDA), and administered by the California Department of Education.
