*A "handler" is any person who handles, processes, ships, or distributes leafy green products\* for market, whether as owner, agent, employee, broker, or otherwise.*
3. The following products are covered under the Leafy Green Products Handler Marketing Agreement:  
*iceberg, romaine, red leaf, green leaf, butter, and baby leaf (immature) lettuces; escarole; endive; spring mix; spinach; cabbage; kale; arugula; and chard.*
3. Review the LGMA-accepted Good Agricultural Practices (Metrics) on the LGMA website. ([Download Here](#))  
By joining the LGMA, you agree to be audited by government inspectors to verify compliance with the LGMA Metrics.
